**Call to Order:** President Whitney Hall called the meeting to order at 12:13 pm.

President Hall asked Rachel Mullins (UACCM) to serve as the Associations Parliamentarian for the meeting. Rachel Mullins responded in the affirmative.

**Roll Call:** President Hall stated: Each member institution in attendance at the annual meeting may select two people to cast votes on behalf of their institutions concerning election of officers and constitutional amendments. One voting delegate is from school relations and /or admissions administration and one voting delegate is from registration and/or records. Votes are cast according to member institution roll call. Any other business may be conducted by simple majority vote. Allie Taylor, Secretary, conducted the roll call of ArkACRAO Members for 2024-25. 35 members answered the roll call, representing 27 institutions. A copy of the roll call is included in the Fall Conference folder of the ArkACRAO 2024-2025 Digital Secretary's Notebook.

Approval of Minutes from Business Meeting, October 5, 2023: President Hall (SAU Magnolia) called for the reading of the minutes of the October 5, 2023, Business Meeting. Alisa Waniewski (ATU) moved to suspend the reading of the minutes. Tammy Weaver (ATU) second. Motion passed. President Hall asked for any corrections to the minutes. Hearing none the minutes are declared approved.

#### A. Treasurer's Finance Report, Linda Holland

The Financial Audit will be sent out soon after the conference once the Financial Review Committee is able to review it as well. Treasurer Linda Holland reports that we are on budget as association. The CD we have in place has not been touched in 10-15 years and just reached \$9,800 this year. The past 3 years we have had non-budget friendly conferences causing the audit committee to recommend that we cut

some things out of the budget for this year for example, not having t-shirts at the conference this year. Treasurer Holland met with the sales director before this meeting and discussed costs of our current conference and it looks to be that there will be around \$20,000 (without the CD) remaining in the budget after this conference. Depending on the vote today, we may have to dip into the extra funds to help pay for the next conference.

Several other things have not been paid yet due to the wait for those receipts and final amounts. We did purchase laptop computers (around \$1,500 for 4 laptops) to use during events and conferences which have cut a lot of the AV costs for our conference. Treasurer Holland states that the Finance Committee has done a wonderful job at cutting a lot of our costs down.

## B. Annual Financial Review Committee, Chairperson, Chris Mosley

President Whitney Hall shared that due to unforeseen circumstances and Chris Mosley's absence due to a sudden sickness, the Annual Financial Review Committee was unable to review the finances. At this time, they do not have a report, but as soon as the report is available, they will review and submit their findings electronically to the membership.

#### C. OFFICERS AND EXECUTIVE COMMITTEE REPORTS

**President, Whitney Hall**: President Whitney Hall (SAU) gave the following report:

Vice President for Information Technology, Heath Riddle-Sims: Vice President Heath Riddle-Sims gave the following report:

Technology points of interest since 2023-24:

ArkACRAO EC approved and purchased four laptop computers. These are to alleviate costs of technology during conference and additional workshop gatherings. The VP of Technology will house these and should be contacted if you are hosting one of our workshops.

For the second year, we have utilized MemberClicks to house a digital ClearingHouse Calendar. After feedback from last year's fall conference, we were able to add which high schools would attend events (given the hosting party shared that information) as well as assigning events to ArkACRAO designated regions of the state.

**Legislative Liaison, Dylan Herekamp:** Secretary Allie Taylor (UAF) gave the following report on behalf of Legislative Liaison, Dylan Herekamp:

Dylan Herekamp was not able to be here today. He had to step away from this ArkACRAO leadership position after accepting a new role at another institution beginning on August 1. On His behalf, he wanted to publicly commend the association for giving him the opportunity to serve in many capacities of the last several years while working as the registrar for Ozarka College, volunteering in ArkACRAO professionally impacted him and he recognizes Madam President Hall as an excellent example to have as a professional mentor. With Dylan stepping down two months prior to the annual meeting, it was a collective decision to keep this ex-officio position vacant until the incoming president appoints a new member this fall.

**Publications/Publicity Chair, Alexis Scrimshire:** Chairperson Alexis Scrimshire (ATU) gave the following report:

Due to some turnover at the Arkansas Department of Corrections, who prints the Quickbook, the original estimate of production of the Quickbook had increased to, \$1,312.50, nearly double what it had been the previous year. As a result, we reached out to 7 different printing companies to get quotes on printing the Quickbook. After discussion with President Hall, Treasurer Holland, and VP Simms, it was decided to order 200 less books and to only print black and white. This along with some other discussions with the Arkansas Department of Corrections reduced the price to \$715.00 plus tax, which was under what we had paid last year.

It was brought to our attention that ArkACRAO is the only group in the ACRAO organization that produces the Quickbook. With increasing cost of paper and printing, the production of the Quickbook maybe something that the membership wants to have discussions on in the future.

**Historian Chair, Jennifer Wright-Cunningham:** Secretary Allie Taylor (UAF) gave the following report on behalf of Historian Jennifer Wright-Cunningham:

Jennifer transitions into a new institutional leadership role outside the scope of ArkACRAO in June 2024. Thankfully, she was willing to fulfill this year's commitment as an ex-officio member of the

executive council yet was no longer able to attend this business meeting, sadly. In her report, she shared that any member of the association will continue to have the ability to share the past practices or data for leadership and other chaired positions to refer to at any given time. An ArkACRAO Google Drive has been created by Vice President Riddle-Sims protected from institutional turnover and documents that were submitted to her were placed in this archive. Jennifer sincerely appreciates the opportunity to serve not only as historian, but also her time on the Statement of Good Practice Task Force. Following this annual meeting, the incoming president will appoint another member in this role.

### **GENERAL STANDING COMMITTEE REPORTS**

**Constitutional Review, Chairperson Casey Martin:** Chairperson Casey Martin (NPC) gave the following report:

Constitutional Review Committee was tasked with the following consideration:

• To review Article I, Section 1 and 2 of the ArkACRAO By-laws for revisions regarding annual membership fees.

The review committee conducted research regarding the fee structure for other regional ACRAOs. With the knowledge that the Association needs to increase its funding to function effectively and provide services to its members and with seeing that there are some ACRAOs that have higher annual fees, the Constitution Review Committee recommends the following revisions to Article I, Section 1 and 2 of the ArkACRAO By-laws. The proposed changes were distributed electronically via the list serv for review before the conference with the membership price comparison document and are also available for review on the conference PowerPoint slides.

## BY-LAWS ARTICLE I -MEMBERSHIP Section 1.

Institutional Member - Individuals designated by each institutional member shall be eligible to conduct Association affairs, to hold elective office, and to participate in other ways. (Other individuals may be invited to serve the Association on committees and in other capacities.) Institutional Members can have unlimited individual members. This membership is voting. The annual fee for each institution is based on the total institutional enrollment from the previous fall semester published by the Arkansas Division of Higher Education. The Annual Fees Table below lists the fee breakdown shall be \$150.

Section 2. (clause 3)

Associate Membership – \$150.00 annual fee – Organizations who have purposes parallel with those of ArkACRAO, who are not otherwise eligible for any other membership designation. Associate Membership is non-voting. Institutions that are candidates for membership to one of the six regional accrediting agencies 8 may apply for associate membership by providing proof of candidacy status. Candidates for associate membership must petition the Membership Committee, meet qualifications for membership, be approved by the Membership Committee, and be approved by a majority vote of the general membership. Once approved, Associate members may participate in the Association's non-voting activities, including Articulation Workshops at the level determined by the Articulation Workshop Committee, and may participate in the Association's listsery. There shall be an annual fee of \$150 for each institution.

With this change, we also expect to see an increase in the cost of the ClearingHouse Calendar for those that only purchase the calendar but are not seeking membership. This cost increase will be \$250. That change does not require a vote by membership.

It has been an honor to serve as your 2024 Constitutional Review Chair. I would like to express my thanks to Heath Riddle-Sim (Hendrix) for the submission and assistance with the initial research for this proposed change and for the committee members Caleb Knight (OBU) and Marisa Grippo (SAU) for their time and efforts in reviewing the drafted changes.

President Hall states that according to Article 4 Section 1 of the Constitutional amendment section of our document amendments and revisions of the Constitution require two-thirds majority vote while the bylaw section, which is what the change above falls under, only requires a majority vote. Chairperson Casey Martin motions to make a change to the ArkACRAO bylaws to be revised as proposed to add additional fees tabled to increase membership for the entire association under the institutional membership. Past President Tracy Finch (ASU) seconded. President Hall asked if there is any discussion. Chad Cox (UAF) asked for discussion on looking at breaking up the middle section of the table above. Chad Cox amended the motion to continue with the above membership annual fee table. Brandy Tripp (ATU) made a motion to change the enrollment structure on the above table and keep the fee structure. The motion is to reflect the changes to the table shown below:

#### **Site Selection, Chairperson Tod Martin:**

President Hall states that members were informed about the rising cost of the previous three conferences that we've already reflected a few times throughout today's meeting, which we encourage everyone to fully consider upon this vote for the 2026 site selection area. Executive Committee, Annual Program Committee, as well as those that have expressed recommendations from the Annual Financial Review Committee this past year and their findings, we really tried to intentionally reduce costs throughout the entire year as well. Some of those expenses were hospitality with the types beverages, t-shirts, and AV costs. We all agreed we did not want to increase the registration fee for each individual person but rather increase the late registration fees to encourage everyone in the future to register early in advance.

Chairperson, Tod Martin (Harding) gave the following report:

Searcy Eldorado Ft. Smith Convention Center Ft. Smith Wyndham Hotel.

We were originally looking at 3 locations, but when we inquired at the Wyndham in Ft. Smith about room rates for a conference at the adjacent Convention Center, the Sales Manager also sent us information about their banquet rooms and catering, and the Wyndham emerged as a fairly cost-effective option compared to the Convention Center in Ft. Smith, so I'm including it here. I think the Convention Center is accustomed to hosting much larger events than our event, and they appear to be priced accordingly \$\$\$\$.

I was able to visit Searcy (obviously) and Eldorado in person and take photographs, but have not been able to do that for Ft. Smith. I'll be inserting web links into the PPT for images of things in Ft. Smith.

I've tried several times to get room rates for the Fairfield Inn in Eldorado but have not yet received a response. I'll send that information if it arrives before next week. Guest Quarters in Eldorado is a unique concept where they have a central office for check-in, but the actual lodging rooms are apartments scattered around the courthouse square in downtown Eldorado. Many of them are second floor, some with balconies, several around a courtyard near a restaurant. Pretty charming and not a bad price for what they offer, about a 3-4 block walk to the Convention Center. The Haywood in Eldorado is across the street from the Convention Center.

In Searcy, Harding has a hotel on the 3rd and 4th floors of the conference center (2nd floor), and many will want to stay there, but there aren't enough rooms for everyone at that location. The Hampton Inn in Searcy is a couple of miles away near the freeway, and it's the newest and highest rated hotel in

town. The hospitality room could be at that location, as the Harding hotel is on campus, and we're an "alcohol-free" campus.

After reviewing the pros & cons of each potential site for the 2025 conference, and discussion amongst committee members related to the details of each site, the committee originally recommended the Searcy, Arkansas location. Hospitality Chairperson Ashley Henry-Saorrono made a motion for the recommendation of hosting the 2026 Fall Conference in Searcy, AR. Luke Kordsmeier (UACCM) seconded the motion. President Hall opened the floor for discussion. After discussion, Chris Riggins made a motion to amend that the two lower cost locations presented (Searcy and El Dorado) be voted upon individually by hand. This is a majority vote by all people. Treasurer Holland has seconded this motion. The membership voted (55 votes) in favor of having the 2026 conference at the El Dorado location. 50 votes were for the Searcy location. The 2026 site location will be in El Dorado, AR. It was recommended that we look at a two-year rotation for better pricing for our conference hotels.

Membership, Chairperson Vacancy: Vice President Ashley Berry (UCA) gave the following report:

Vice President for School Relations, Ashley Berry, will present the following Membership Committee report for consideration, in lieu of a chairperson vacancy.

Since the last annual meeting, ArkACRAO received two (2) applications for Associate Membership. According to Article I, Section II of the association's bylaws, interested organizations who have purposes parallel to with those of ArkACRAO must meet the candidacy criteria for associate membership by applying and providing proof of institutional status from one of the six regional accrediting agencies.

Associate Membership status is recommended for:

- 1. Murray State located in Murray, KY applied June 24 for consideration; the institution is accredited by the Southern Association of Colleges and Schools Commission on Colleges.
- 2. University of Missouri located in Columbia, MO applied September 16 for consideration; the institution is accredited by the Higher Learning Commission, a commission of the North Central Association of Colleges and Schools.

Additionally, ArkACRAO offers educational agency membership for state educational boards or agencies of higher education. Members of this status receive the same benefits as Associate Members. One (1) application was submitted to ArkACRAO for Educational Agency Membership status and is recommended for:

1. Virtual Arkansas – located in Plumerville, AR – applied May 16 for consideration; the organization's mission is to equip, engage, and empower Arkansas schools, students, and teachers by providing equitable access to superior online education – which is implemented through a partnership with ADHE and AESC by providing an array of quality digital courses to

public school students. It is not an online high school or a diploma-granting institution but a resource for supplementing educational programs to Arkansas school districts through all Education Cooperatives including content and teacher service, content partnership program, learn anywhere academy, ALE core service, summer school, and dedicated teacher program to name a few.

Vice President Ashley Berry (UCA) made a motion to grant associate membership status to Murray State and University of Missouri, as well as granting educational agency membership to Virtual Arkansas, based on the criteria within our bylaws. #### **Admissions Administration and School Relations Standing Committees:**

I. Articulation Workshops, Chairperson Rebecca Willems: Vice President Sydney Welch (UCA) gave the following report on behalf of Rebecca Willems (University of the Ozarks):

#### 2024 Host Sites:

- East Williams Baptist University Walnut Ridge
- South Southern Arkansas University Magnolia
- North University of Arkansas at Fort Smith Fort Smith

#### New Changes:

- Having the East Host site start at 1 pm was more beneficial for both the host site and the attending college representatives. The host site was able to have time to set up their campus and not have to come in on Labor Day. This also allowed colleges to come up the day of the workshop instead of driving up the day before.
- College presentation rotation this year was based off the host sites. It was just a coincidence that this year hosts were told the end of the alphabet, so this year's presentations went Z-A.
- Workshop Chair could possibly get contact information for the high school principals. This would help contact more high school representatives when turnover would occur. We would still contact counselor representatives and invite them, but also include principals to help touch base with counselors we possibly missed.
- Allow college representatives be there at 7:30. This would allow them to set up their tables and grab breakfast before high school representatives started to show up.
- Workshop chair would email the host sites the check-in QR code to display on the presentation screens to allow college and high school representatives sign-in, if they were missed at the table.
- Start inviting high school representatives to the workshop early to mid-August. We would mass email the contacts that we have on file and use the contacts that we gathered from this year.
- Possibly adding a deadline for representatives to sign up. Creating a deadline for Labor Day for sign-ups would help give colleges and host sites time to gather materials for each event.
- Create the check-in QR Code to auto-populate the representative's information for faster check-in capabilities. Most representatives have their contact information already saved on their phones for other events.
- Have a ArkARACO staff member walk through the check-in line as people are waiting to help check people in faster.
- In the email communication that the articulation chair sends out, maybe include information on what high school representatives should bring: rolling buggie/suitcases, pen, notebook
- Ask college representatives to stay the entire time for all college presentations
- Change the label names for the following. This will help eliminate the confusion of check-ins:

II. College Planning Programs, Chairperson Mary Whiting: Vice President Sydney Welch (UCA) gave the following report on behalf of Mary Whiting (UA Monticello):

#### Positives:

- The majority of the hosts/hostesses were agreeable and willing to work with me.
- I was able to consolidate some areas.
- Statement of Good Practice was given to everyone involved.
- I shortened times wherever possible.
- I continued to try to keep regional fairs within proximity, but there were a few exceptions because of no other choice.
- Professional dress of college reps.
- Courtesy and praise from hosts/hostesses about college reps.

#### Negatives:

- Everyone adhering to the Statement of Good Practice.
- Some hosts/hostesses choosing to try and change their times without discussing it.
- Changing counselors/administration at schools with no notice and then wondering why I didn't know.
- Complaints about refreshments from college reps. This is totally the decision of the host/hostess.
- Students not using scanner registration.
- Students not interested in even being there.
- Some schools refusing to consolidate because of "unreasonable" statements.
- Needing to include private schools/charter schools in certain areas and refusing to do it(hosts/hostesses.)
- III. College Fair Automation, Chairperson Rebecca Castillo: Chairperson Rebecca Castillo (Hendrix) gave the following report:
  - In February during SACRAO, we met up with StriveScan to learn more about their services, discussed pricing, and how this could potentially benefit ArkACRAO College Planning Programs
  - The StriveScan team worked with Vice President Riddle-Sims on pricing based on how many college planning programs we have, what we were paying Go To College Fairs, and bundled packages vs paying for individual credits
    - We settled on a \$900 bundle rate for 60 ArkACRAO college planning programs in the fall semester. The bundles do not work for out of state fairs

- This packaged rate is 47% cheaper than what institutions were paying with Go To College Fairs
- President Hall and Vice President Welch scheduled a demonstration and information session
  with President Elect Beard, Vice President Berry, and Vice President Riddle-Sims at the end of
  February 2024 to allow the StriveScan team to present their service to more Executive Council
  members who work closely with areas of Admissions
  - Following this meeting, it was decided to bring this to the rest of the Executive Board during the March meeting
- Once a vote was taken, the first ArkACRAO Town Hall meeting was created and held in April 2024 for members to come and learn about StriveScan and voice their opinions and concerns about switching
- Vice President Welch received positive feedback regarding the switch. After a vote, ArkACRAO officially switched from Go To College Fairs to StriveScan
- The StriveScan team provided flyers and information to give out to high school counselors at the annual ArSCA conference in June. They also came to the Articulation Workshops in September and the first week of college planning programs the week after
- We are excited for this new partnership and how it can continue to better our state for events.

Brandy Tripp (ATU) made a motion to approve the Office and Executive Committee Reports. Dr. John Proctor (SEARK) has seconded the motion. The motion passed.

- A final revision had been voted on by the Executive Council in May 2024
- In August 2024, an urgent matter had been brought to the attention of the Executive Council regarding the use of stickers attached to information pieces during college planning programs. After discussion and a vote, the Executive Council approved distribution of stickers at college planning programs for fall 2024.

President Hall states that scholarships were paused this year for the ArkACRAO conference. We also provide a SACRAO conference scholarship for \$250 this past year.
